OBTAINING COVID-19 VACCINATIONS FOR YOU AND YOUR WORKFORCE

Every state is in the process of rolling out a vaccination plan for its citizens. Although each state vaccination plan is unique, <u>many include an option for vaccinating employees of critical industries in</u> <u>one of the top-tier categories</u>. California, for example, will vaccinate critical infrastructure employees in Phase 1B Tier 2, while Tennessee will vaccinate critical infrastructure employees in Phase 2a, which is still ahead of many other population categories.

RIPA wants you and your employees to be healthy and the best way to ensure everyone's health is to obtain vaccinations as soon as practicable.

We suggest that you consult your state health agency website to obtain information about their vaccine roll-out plan. Most states have a link to their plan at or near the top of their COVID-19 information page. Read the plan carefully and look for references to "critical industry sectors", "essential workers" or similar terms. If you have any questions about the way your company and its employees are classified under your state plan, contact the agency directly or call RIPA – we'll be glad to contact the agency on your behalf.

When it is time for you and your employees to receive their vaccinations, we suggest you take the following steps to maximize participation:

• Talk to your employees about the benefits of vaccination for them, their families and coworkers (see guide below); and • Issue all workers a letter on company letterhead (see below) which they can present at the vaccination site to ensure they are accepted for vaccination.

Sample Letter for RIPA Members Regarding the Administration of COVID-19 Vaccines to Employees of Essential Businesses

Importantly, our state has recognized the CISA guidance for the designation of critical industries throughout the course of the pandemic.
