



ELIGIBILITY

To apply for membership in RIPA, your company must have been in business for at least one year prior to application.

TO APPLY

Mail the completed application, accountant's certification form (opposite) and appropriate membership dues to:

Your application for membership will be announced to all members by email and in the next newsletter. RIPA members will have 30 days to comment, following which you will be notified regarding the status of your application.

DUES STRUCTURE

Dues will be paid on all sales reported on line 1a of the company's annual tax return (IRS form 1120). The most recently completed fiscal year prior to application should be utilized to determine the sales base. Sales must be certified by an accountant. Companies paying the maximum membership dues need not submit an accountant's certification. There will be no exclusion of sales, with the exception of sales derived from unrelated business activities. In cases of common ownership of multiple companies, the largest company in the group will certify sales based on Line 1a of their IRS Form 1120; other companies in the commonly owned group will certify sales based on Line 1a of IRS Form 1120, less intra-company sales made within the group.

Payment is due in full at the time of application, and at the first of the year thereafter. A business joining mid-year pays a full year's dues, but will be credited a prorated amount the following year accordingly. Members who have been members of RIPA for one year, may make quarterly payments. Members electing to pay quarterly will pay a 10% surcharge. Each quarterly installment is due prior to the first day of each quarter. If you have any questions, call the RIPA office at (301) 577-3786.
